

MUTUAL LAW ENFORCEMENT ASSISTANCE MOU
BETWEEN THE CITY OF VANCOUVER AND THE CITY OF CAMAS
FOR TRAFFIC ENFORCEMENT PROTOCOLS FOR UNION HIGH SCHOOL

THIS MEMORANDUM OF UNDERSTANDING ("MOU") FOR MUTUAL LAW ENFORCEMENT ASSISTANCE MOU is entered into by and between the City of Vancouver ("Vancouver"), by and through the Vancouver Police Department ("VPD") and the City of Camas ("Camas"), by and through the Camas Police Department ("CPD") set uniform protocols for VPD officers performing traffic enforcement duties on NW Friberg Road immediately in front of Union High School, within the Evergreen School District #114 ("ESD #114").

This MOU is entered into pursuant to authority granted by Ch. 10.93 RCW and Ch. 39.34 RCW, and subject to all consistent terms and conditions of that certain Master Interlocal Mutual Law Enforcement Assistance MOU ("Master MOU") executed in 2000 by the parties, and recorded with the Clark County Clerk's Office under Recording Number 3379036, except as expressly provided herein.

Therefore, for and in consideration of the following covenants, the parties agree as follows:

1. **Effective Date and Duration.** This MOU shall be effective from the date the MOU is executed by the last agency signing the MOU and shall renew automatically on the first day of each following January thereafter unless terminated in accordance with the provisions of the Master MOU between the parties.
2. **Purpose and Function.** The purpose of this MOU is to establish protocols whereby VPD will enforce traffic regulations along that portion of Friberg Road that fronts Union High School within the Camas City limits.
3. **Description and Jurisdiction of Enforcement Area.**
 - a. Evergreen School District #114 has constructed a new school known as Union High School, on a parcel of land within the Vancouver city limits west of NW Friberg Road and north of SE 1st Street. The school property is more fully shown as the area denoted "Evergreen School District #114 Annexation Area" in the ESD #114 Annexation Map, attached hereto as Exhibit A (hereafter referred to as "the NW Friberg Road enforcement area").
 - b. NW Friberg Road lies within the Camas city limits.
 - c. Union High School's parking lots can only be accessed from NW Friberg Road, which fronts the entire length of Union High School to the east of the school.

- d. Vancouver has jurisdiction to enforce all traffic and criminal law violations that occur on Union High School property.
- e. Camas has jurisdiction to enforce all traffic and criminal law violations which occur on NW Friberg Road.

4. **Protocols for Enforcement Responsibilities in NW Friberg Road Enforcement Area.**

The parties agree that in the NW Friberg Road Enforcement Area:

- a. In general, VPD shall be primarily responsible for enforcement of school-related traffic safety issues such as speed and other minor traffic-related infractions under state law (including those infractions set forth in the Model Traffic Ordinance, WAC 308-330, as adopted by the Camas City Code).
- b. Examples of the type of enforcement VPD will undertake include enforcement of violations regarding school zone speed limits, bicycle and pedestrian safety. The examples are meant to be illustrative, only, and are in no way intended to limit VPD's authority to enforce traffic regulations except as set forth in this MOU.

5. **Development of Additional Protocols.** The Chiefs of the respective agencies, or his/her designee, may meet from time to time to develop, revise or amend the protocols in this MOU.

6. **Modification.** This MOU may be amended by the mutual written agreement of the parties, signed by the duly authorized representative of each.
