YOU WILL BE NOTIFIED OF THE OFFICIAL DECISION. IF POLICE RESPONSE IS NOT REINSTATED, THE \$50.00 FEE WILL BE REFUNDED TO YOU.

FALSE ALARM FINES:

A false alarm is the activation of any security alarm system by other than forced entry, attempted forced entry, unlawful entry, or actual burglary or robbery at the alarm site. Alarm users are responsible for paying false alarm fines regardless of age or economic condition.

2 nd Response within 12 months of 1 st response	\$ 100.00	
3 rd Response within 12 months of 1 st response	\$ 150.00	
4 th Response within 12 months of 1 st response	\$ 200.00	
5 th Response within 12 months of 1 st response	\$ 250.00	
6 th (or additional) Response within 12 months of 1 st response	\$ 300.00	Disconnect**

*A waiver request form will be mailed with each notice of a 1st false alarm. The 1st false alarm response fee may be waived if the alarm owner agrees in writing to take responsibility for the alarm system and states that corrective action has been taken; however, the 1st false alarm response will remain on record.

**Notice of Suspension of Police Response and permit revocation may be sent to the alarm owner, alarm company, and 911 after the 6th false alarm.

***A late penalty of \$20 and standard collections processes will commence upon non-payment of any invoice.
