



With the passage of Washington State Initiative 940 and SHB 1064, incidents where the use of deadly force by a peace officer results in death, substantial bodily harm, or great bodily harm, require an independent investigation. Here is the link to [Washington Administrative Code](#) (WAC Chapter 139-12).

The Independent Investigation Team (IIT) will consist of a team of qualified and certified peace officer investigators and at least two non-law enforcement community representatives who operate completely independent of any involved agency to conduct investigations of police deadly force incidents.

An IIT is created when multiple law enforcement agencies enter into a written agreement to investigate police use of deadly force incidents in their geographical regions. A single law enforcement agency may fulfill the independent investigative function, provided it is not the involved agency.
