### To appeal, please provide:

- Original Parking Notice of Infraction, which <u>must be signed and completed</u>
- Appeal Form (optional)
- Supporting photos or documents (optional)

Appeals must be received or postmarked by the City of Vancouver within thirty (30) days of date issued, or if the notice of infraction is mailed, thirty-three (33) days from the date it is mailed, pursuant to RCW 46.63.060(2)(h).

# **Appeal Process Information**

- IMPORTANT: Do not appeal your Infraction if you are not willing to attend a hearing before District Court.
  - -Appeals will <u>not</u> be handled over the telephone.
  - -Read your Infraction carefully, complete the back of your Notice of Infraction and sign
  - -Check one of the boxes on back of your notice of Infraction.
  - -If you select #2, Payment Plan, you admit fault, and District Court will provide you with further information.
  - -All submitted documents remain the property of the City of Vancouver. Please make copies for your records. -Clark County District Court will notify you when your hearing is scheduled.

## Payments submitted with or before Appeal

-If payment is received independently and before your appeal, payment will be applied to the Infraction and your appeal will not be considered.

-If you submit payment with your appeal and you select response option 1 on the back of the Infraction, your payment will be applied to the Infraction and your appeal will not be considered.

-If you submit payment with your appeal and you select option 2 or 3 or 4 on the back of the Notice Infraction, your payment will be returned to you.

## **Incomplete Appeals**

If you do not complete the back of the parking Infraction when submitting your appeal, your appeal will not be processed and you may lose your right to file an appeal and a late penalty may be asse ssed.

# Failing to Display Your Disabled Placard

Your parking Infraction may be administratively dismissed if:

- You received a Notice of Infraction for failing to display a disabled placard; and Your violation reads RCW 46.16.381(9) (violation information on the front of the Infraction); and You are able to provide a copy of the following information:
  - 1. Disabled placard showing the valid dates;
  - 2. Photo ID;
  - 3. WA Placard Holders will also need to provide a copy of a matching and valid State of Washington "Individual With Disabilities Parking Privilege" identification card issued by the Department of Licensing.

If you do not submit all documents required, your parking Notice of Infraction may be forwarded to District Court.

### Parking in a Striped Access Aisle or Unauthorized Use of a Disabled Placard

All Infraction appeals for Parking in a Striped Access Aisle [RCW 46.16.381(8)] or for Unauthorized Use of a Disabled Placard [RCW 46.16.381(7)] - {See violation information on the front of the ticket}, will be forwarded to District Court.
