Item 2: Approval of 3/13/24 Minutes

Item 3: Lodging Tax Program Resources & Budget

Natasha Ramras, CFO, provided a presentation and reviewed the tax-supported bonds and the Lodging Tax Revenue from 2019 to 2023. Committee member Bowers asked about the guaranteed balances that are not utilized and how much is available. Discussion occurred around available Lodging Tax funds and how to allocate those funds and the possible expansion of the Convention Center. Jonathan Young provided feedback regarding the biennial and supplemental budgets.

Item 4: LTAC Grant Program Criteria & Impact Reporting Evaluation Kick-off

Matthew Landkamer, Wherabout Travel, presented the phases and goals of the Lodging Tax Grant Program evaluation project. Discussion occurred around changes to the Lodging Tax process including the application questions, timeline to apply, scoring criteria, data reporting and barriers that impact applicants. 
