**Vancouver Climate Strategy:** The City of Vancouver is preparing a greenhouse gas (GHG) inventory and climate strategy report to guide the city toward a low-carbon future that sustains a high quality of life for residents. A cornerstone of this process is to ensure **inclusivity and equity**. The City is committed to providing an open and inclusive community engagement process with ample opportunities for residents, businesses, and other community partners to provide feedback and participate in the planning process.



**Accessibility of City Buildings and Services:** The City of Vancouver is committed to providing access for people with disabilities to its public programs, services, buildings and activities. By improving our buildings, parks and streets, responding to requests for accommodation, ensuring non-discrimination in our hiring practices, providing information in accessible formats and more, we seek to make Vancouver a

welcoming and diverse city where everyone can access, and participate in, their City government programs, services and events.

As part of this ongoing effort, the City is updating its Americans with Disabilities Act (ADA) Transition Plan this year, and we need our community's feedback on how we're doing and what may need improvement when it comes to the accessibility of our buildings, parks, streets, jobs, programs and services to people with disabilities.

Feedback will be accepted on this page throughout the ADA Transition Plan update process, which is anticipated to be complete by the **end of 2021**. Your input will be used to help identify potential barriers to access that will be included in the new transition plan. The community will also be invited to review and provide feedback on the City's draft transition plan when it's complete.



**Homelessness Response Plan:** Addressing the growing impacts of homelessness is a top priority at the City of Vancouver.

While Clark County remains the lead agency in addressing the systemic issue of homelessness in the region, the city has a plan to address its immediate impacts to community health, cleanliness, and safety, including:

- Garbage, trash and clutter in public spaces
- Residents living in tents/vehicles in public rights-of-way
- Livability concerns for the unhoused, including the removal of barriers to accessing services

A snapshot of current City efforts to mitigate the safety, cleanliness and health impacts of homelessness is provided, along with an opportunity to provide input and ask questions.



**MyVancouver Mobile App:**

Get this free phone app for a wide variety of City services and information. It provides Vancouverites with a direct, convenient line of communication with City employees

to solve non-emergency issues and be informed of City events and resources.

### **Minutes CPNA General Meeting, May 26, 2021**



Judi Bailey from the Office of Neighborhoods set up the meeting just ahead of our 7pm beginning time. Central Park Neighborhood is set up to make use of the city's Zoom capabilities. As participants were signing in, Mayor Anne McEnery-Ogle was talking about the most recent city council discussion on the homeless camping situation. They heard from Jamie Spinelli, the homeless resources coordinator, on possible solutions to the camping crisis around Vancouver. The idea being discussed is to provide several fenced encampments that would have a camp host, access to water, toilets, health care and security. Q: Why doesn't the city provide hotel rooms to the homeless? A: The city

has several resources for homeless including churches, the Howard Johnson's currently being remodeled, men and women's shelters and several other options. At this point, Jim called our meeting to order. Those present included Jim Thomas, Pepper Kim, Sylvia Bailey, Norma Watson, Lyn and Janine Ayres, Judi Bailey, Anne McEnerny-Ogle, Officer Sean Metevia, Brooke Porter, Brandi Osborn, Katie Matsuura, and Steven Hamaker.

Officer Metevia reported that Central Park has had a rise in the number of catalytic converter thefts, especially from Toyota Prius, and including trucks. He cautioned us to never leave our vehicle unattended while warming it up. Lastly, thefts include items from truck beds and bikes taken that are left out. Apparently, bikes are taken apart for the purpose of augmenting them into other bike-like vehicles. Q: What is the rule on parking in public areas for long periods of time even if the vehicle is moved occasionally? A: If we email officer Metevia about specific vehicles, he will run a registration check.

Jim continued the meeting with a vote to accept the minutes as corrected and posted on NextDoor and on the city website. Sylvia reported that our balance in the treasury is \$1,326.87. She asked for direction on sending \$100 to the VNA to renew our insurance. We decided to go ahead and renew.

Our guest speakers, Brooke Porter (Outreach Coordinator with Public Works) and Brandi Osborn (Pavement Management), continued with a discussion on pavement management. Brandi spelled out the various ways the city paves, preserves or rehabilitates the road surfaces so we will understand why they chose to rehabilitate Grand Place and E. 13th Street this summer. We will also see speed humps replaced and striping repaired. Brooke discussed the funding sources as well as the order of the process here in the neighborhood. Ramps will go in first, then pruning, then advanced notice using door hangers and postcards to those property owners directly affected. Street closure is the last step to prepare for the contracted work to begin. Q: Will the two streets be done at the same time? A: Yes, including the intersection of both streets. Q: Who actually puts the door hangers out? A: The contractor assigns one of his crew to do that job. Q: There is striping improvement needed just west of the work and we wonder if that could be repaired. A: We will work with the contractor to include that repair during this work. Brooke agreed to send along phone numbers to pass on to neighbors who might need to contact someone regarding the repairs, access and/or closure of either of the streets. She also stated that the plan is to have the least impact on homeowners.

Jim asked for any other business to be brought to the floor. Sylvia brought up the need to elect a new president as Jim has requested to be relieved of his position. Norma asked Judi Bailey whether she had any words of wisdom on how to handle the lack of volunteers stepping up into positions. Many neighborhoods are experiencing this problem of loss of people to support the associations. We began discussion on why so few people stay interested and connected to their neighborhoods. Judi feels that eye to eye contact is the most authentic and successful action to take. She suggested asking everyone to reach out to their next door neighbor and the neighbor across the street from them on a regular basis. We began making a list of things we could do to get neighbors to feel more connection. Q: Have we made an effort to actually go door to door to inform people of the existence of Central Park Neighborhood Association? A: Prior to Covid restrictions and before NextDoor we did have newsletters delivered by hand. Judi also mentioned that each neighborhood has a once a year benefit of post cards to be sent out to everyone in the neighborhood. Pepper mentioned that when she and Lydia walk, they openly approach other walkers and this always has a positive result. Anne suggested a “freedom day” in our Quarnberg Park for this 4th of July with free ice cream with the idea that we would create a time and place to reconnect with neighbors.

Pepper announced the Clark County Historical Society will be having a scavenger hunt on Main Street on June 12. The program will be orchestrated for cyclists, pedestrians and history buffs.
