2022 Action Plan Substantial Amendment

Cancel –City Set-aside \$300,000 CDBG Fourth Plain Commons; Reallocate \$300,000 CDBG to Homeowner Rehabilitation Program

It was previously anticipated that this CDBG set-aside funding would be utilized to provide payment on the Section 108 loan for Fourth Plain Commons. Due to delays in project completion, the initial installment payment for this project will not be due until August 2025. These reserved funds will be repurposed to the City-operated Homeowner Rehabilitation Program to assist homeowners with low- to moderate-income make needed repairs to their home.
