In accordance with VMC 5.85.120, no ambulance license shall be issued, nor shall license be valid after issuance, nor shall ambulance be operated in the City, unless operator maintains insurance policy or policies against claims for injuries to persons or damages to property which may arise from, or in connection with, operation of ambulance company. Such insurance shall name City of Vancouver as additional insured, and ambulance company shall also indemnify and hold City of Vancouver harmless from any causes of action arising from operation of ambulance company.
