

## Neighborhood Watch Program



The Airport Green Neighborhood continues to have one of the lowest crime rates in the City of Vancouver. Much of the credit can be attributed to our Neighborhood Watch Program. If you're not familiar with Block Watch or Neighborhood Watch, it can be summed up on "neighbors watching out for neighbors." This is not a new concept, but it does require a new attitude when it comes to urban living. Success of the Neighborhood Watch program depends on neighbors knowing their neighbors and offering mutual aid to prevent crime. The mutual aid can take the form of calling neighbors late at night (even if it means waking them) to let them know that their garage door is still open. It can also mean calling 3-1-1 to report suspicious activity, or 9-1-1 in case of fire or other emergency.

Neighborhood Watch is not intended to promote spying or to invade privacy. But knowing who your neighbors are and recognizing their normal habits can be helpful in determining what constitutes suspicious activity. If you get the feeling that something is not quite right about seeing an unfamiliar man walking away from your neighbor's house carrying a power tool at a time when that neighbor is normally away at work, then that would be a suspicious situation and warrant a call. Watching out for your neighbors and knowing that they are watching out for you, too, contributes to a feeling of security and instills pride in the neighborhood.

The Airport Green Neighborhood is organized into 29 Sections, which are also used for CERT/MYN emergency planning, with Section Leaders as the primary contacts for each section. The map on the reverse side shows the Watch Sections for AGNA. The Section Leaders are responsible for maintaining a phone tree for that section. If a police action or a crime occurs, the phone tree can be activated to pass along relevant information regarding the emergency or event. Having your neighbor's phone numbers can also come in handy to notify a neighbor if a stranger is lurking in the yard. Since the Neighborhood Watch program is voluntary, some neighbors may choose not to participate - which is OK. Only participating neighbors, however, receive a copy of the section phone tree.

New neighbors are encouraged to contact their Section Leader in order to be added to the phone tree. The names and phone numbers of the Neighborhood Watch Coordinators are listed for your convenience. AGNA utilizes the Map Your Neighborhood (MYN) to help establish a strong Emergency preparedness and Neighborhood Watch. Call to schedule this opportunity.

### City of Vancouver - Parking Code



#### 19.12.080 Truck, trailer, and motor home parking on residential streets.

A. No person shall park or leave standing on any street or public right of way of any residential area of the city, any of the following:

- 1. A truck with a gross weight capacity in excess of nine thousand pounds;
- 2. A trailer;
- 3. A travel trailer:
- 4. A motor home.
- B. The provisions of this section shall not apply to any vehicle which is parked or left standing expressly for the purpose of loading or unloading. For the purposes of this section, a reasonable amount of time on any day or successive days shall be allowed for loading and unloading, the amount of which time is to be determined according to the nature and extent of the loading and unloading operation. C. Impound authorized. For the purposes of this section, law enforcement officers, including fully and specially commissioned officers, are authorized to impound pursuant to the procedures set forth in R.C.W. 46.55.085. (Ord. M-4088 §1, 2014)

#### 19.12.090 Obstructing Traffic.

No person shall park any vehicle upon any highway in a manner which obstructs or otherwise interferes with vehicular or bicycle traffic upon the traveled portions of the roadway and bicycle lane. (Ord. M-4168 §6, 2016)

#### 19.12.100 Prolonged Parking.

A. No vehicles shall remain parked on a highway longer than 24 hours without a valid permit. Vehicles parked longer than 24 hours may be issued a parking citation.

- 1. A law enforcement officer discovering an unauthorized vehicle left upon a highway shall visibly mark the vehicle and attach to the vehicle a readily visible notification tag. The tag shall contain the following information:
- a. The date and time the tag was attached;
- b. The identity of the officer.
- c. A statement that if the vehicle is not removed within twenty-four hours from the time the tag is attached, the officer may issue a parking citation and the vehicle may be taken into custody and stored at the owner's expense:
- d. A statement that if the vehicle is not redeemed as provided in RCW 46.55.120, the registered owner will have committed the traffic infraction of littering - abandoned vehicle; and

- e. The address and telephone number where additional information may be obtained.
- 2. If the vehicle has current Washington registration plates, the officer shall check the records to learn the identity of the last owner of record. The officer or his or her department shall make a reasonable effort to contact the owner by telephone in order to give the owner the information on the notification tag.
- 3. If the vehicle is not removed within twentyfour hours from the time the notification sticker is attached, the law enforcement officer may take custody of the vehicle and provide for the vehicle's removal to a place of safety. A vehicle that does not pose a safety hazard may remain on the roadside for more than twentyfour hours if the owner or operator is unable to remove it from the place where it is located and so notifies law enforcement officials and requests assistance.
- 4. For the purposes of this section a place of safety includes the business location of a registered tow truck operator. (Ord. M-4168 §7, 2016)

#### 19.12.110 Expired Tabs.

A. No person shall stop, stand or park any vehicle on any street or alley, or in any garage, parking area or other property owned by the City, without first having displayed current and proper vehicle license plates thereon as provided in Chapter 46.16A RCW. The vehicle license plates shall be attached conspicuously in the manner required by RCW 46.16A.200. B. Any person who shall violate or fail to comply with the provisions of this section shall

## Sidewalk Defects and Repair $\underline{A}$

The City of Vancouver is committed to providing safe sidewalks that are readily accessible and usable by all community members. As safe spaces for pedestrian movement and access, sidewalks enhance connectivity and promote an active lifestyle. Repair and maintenance of sidewalks is the responsibility of the abutting property owner per the Vancouver Municipal Code 11.30. When residents report sidewalk concerns, Sidewalk Management staff will inspect the site and issue correction notices to property owners which include information on defects found.

The next page contains examples of common sidewalk defects and acceptable repairs that property owners may perform. Repairs shall follow the City of Vancouver's Transportation standard details (Section T02, Sidewalks, Ramps) and specifications, or be performed as directed by the City Sidewalk Management Program Inspector.

We highly recommend that property owners and/or their contractor contact us at <a href="mailto:sidewalks@cityofvancouver.us">sidewalks@cityofvancouver.us</a> or 360-487-8196 prior to making any repairs.

Before beginning sidewalk maintenance or repairs, property owners or their contractors **must have a valid permit** to work in the right of way.

Permits can be obtained at the permit counter at City Hall, 415 W 6th Street, Vancouver, WA 98660.

## Sidewalk Defects and Repair Continued $\underline{A}$

#### (1) Vertical Separation (Trip Hazard)

A vertical separation occurs when there is more than one-half inch (1/2") between any two panels of sidewalk. Many factors cause vertical separation in sidewalk panels, with the most common being tree roots raising the sidewalk or settlement.

#### Acceptable Repairs

- Remove and replace affected panel(s).
- Mudjack or lift panel manually.
- Grind down affected panels up to 2 inches (2") in height. (This is not ideal when the damage is caused by tree roots because the roots continue to grow and raise the sidewalk, which may require future additional repairs.)

#### Note

- ¼ inch to ½ inch vertical separations should be beveled or ground down to remove the separation.
- If grouting or some type of patching is used to temporarily repair the vertical separation, a permanent repair on the Acceptable Repairs list will be required in the future.
- If grinding down or grouting more than a ½" of vertical separation, the slope of the repair shall be no steeper than 1:12 (8.33%).

# (2) Horizontal Separations (Openings) or Cracks

This occurs when the sidewalk has openings between panels or cracks of more than one-half inch (1/2") in width or more than 4 cracks in any one panel.

#### <u>Acceptable Repairs</u>

- Filling of cracks with an epoxy crack filler is acceptable for separation widths up to one and one-half inch (1 ½").
- Separations wider than one and one-half inch (1 ½") shall be removed and replaced.
- Panels with multiple cracks (more than 4 in any one panel) shall be removed and replaced.

#### <u>Note</u>

Grouting is a temporary fix and is not a recommended repair because panels can move and break the grout out of the crack.

# (3) Deteriorated Surface (pitting/spalling and holes)

Spalling occurs when the cement has deteriorated and the aggregate below the surface of the sidewalk is exposed one-half inch (1/2") or more in depth or over fifty percent (50%) of a single panel.

#### Acceptable Repairs

- Hole(s) may be filled with grout or an epoxy crack filler. Proper preparation of the affected area prior to the use of these materials is a must for proper adhesion.
- Repair of spalling requires removal and replacement of the affected sidewalk area.

#### Note

- Patching may be used but is a temporary fix. Proper preparation of the affected area prior to the use of these materials is a must for proper adhesion.
- Holes are when the sidewalk has holes or depressions one-half inch (1/2") or more in depth and are three inches (3") or more in diameter.

# (4) Missing Sidewalk (sections/pieces)

If any part of the sidewalk is missing to the full depth, replacement of the missing panel is required.

#### Acceptable Repair

Repair of this condition requires removal and replacement of the affected sidewalk area.

#### (5) Ponding Water on Sidewalk

If the sidewalk has settled allowing water to pond to a depth greater than three-quarters inch (3/4"), replacement of the affected panel is required to restore drainage.

#### <u>Acceptable Repair</u>

Repair of this condition requires removal and replacement of the affected sidewalk area.
