HOME OCCUPATION STANDARDS

You may operate a business in your home only when the following development standards are met, as allowed under Vancouver Zoning Ordinance 20.860.

1. Home occupation must be clearly subordinate to the residential use of the property and will not be detrimental or disruptive in terms of appearance or operation to neighborhood properties.
2. A current and valid City of Vancouver business license is maintained or, if applicable, a valid City business license exemption claim (Determination of Exemption Checklist) is on file. Visit our [City's Business License](#) page for more information.
3. Not more than 25% of the combined floor space of main and accessory buildings or 1,000 sq ft (whichever is less) may be used for business activities. Please submit floor plan of home indicating area to be used for home occupation.
4. Two nonresident employees are permitted (off-street parking must be provided). The person providing the business must reside within the dwelling.
5. Retail sales are prohibited except when the product to be sold is clearly incidental to the services authorized.
6. Signage – one door nameplate or freestanding sign not to exceed 2 sq ft is permitted (refer to VMC 20.860 for more details).
7. No commercial vehicles allowed associated with home occupations.
